> SUBJECT: AMENDING SECTION 3.2.2.4 (c) RULE I OF THE IMPLEMENTING RULES AND REGULATIONS, P.D. 1096 AND THE APPLICATION FOR ELECTRICAL PERMIT FORM.

In view of the representation made by the Institute of Integrated Electrical Engineers of the Philippines thru its National President, to allow the Associate Electrical Engineer and Assistant Electrical Engineer to sign Applications for Electrical Permit within the range for each profession as authorized in Section 38 of RA 184 otherwise known as the Electrical Engineering Law, Section 3.2.2.4 (c) of Rule I of the Implementing Rules and Regulations, PD 1096 which limited the signature to the Professional Electrical Engineer and the Master Electrician is hereby amended including the corresponding form for the Application for Electrical Permit.

The amended provision shall now read as follows:

"3.2.2.4 ELECTRICAL:

- (c) For new, additional or altered electrical installation not exceeding 20 outlets nor a capacity of 4 KW up to 600 volts, application shall be accompanied by a bill of materials and sketch signed by a duly licensed Professional Electrical Engineer, 👢 Associate Electrical Engineer, Assistant Electrical Engineer or Master Electrician containing the following:
 - Single line diagram of electrical 1. installation
 - 2. General electrical layout, with legends
 - 3. Bill of materials
 - 4. Estimate of Cost (for statistical purposes only)."

Correspondingly, the Application Form for Electrical Permit is hereby revised.

Note 1: Electrical permit shall be issued within fifteen (15) days from the payment of the required fees provided the building official is satisfied with the work and, the plans and specifications conform to the requirements of the Building Code and other pertinent rules and regulations. (Section 304, National Building Code).

Note 2: This permit may be cancelled or revoked pursuant to Sections 305 and 306 of the National Building Code.
