NUMBER 62 ^{8/17} SUBJECT: Implementation of Labor-Based Projects under
Dept. Order No. 46, Assignment of Additional
Series of 1988) Responsibilities and Related Matters.

To ensure better coordination and permit wider participation in the implementation of labor-based projects under Department Order No. 46 dated 20 May 1988, all concerned offices of the Department are directed to comply with the following additional instructions and guidelines:

1. All Offices

- 1.1 Make available to the Central Labor-Based Advisory and Training Team (CLATT), upon request, their labor-based personnel, trainers, training staff, facilities and other resources, if and when needed.

2. Bureau of Construction

- 2.1 Assign at least two (2) labor-based engineers, on-call or part-time basis, to assist the CLATT in the performance of its role under Department Order No. 46.

3. Administrative and Manpower Management Service

- 3.1 Provide training administration services to the CLATT in the implementation of its inter-agency training courses.
- 3.2 Provide coordinative, technical and financial assistance to the regional offices, in the nationwide implementation of the labor-based training courses of the Department.

4. Regional Offices


- 4.1 Ensure strict compliance by all district/city offices with the guidelines under Department Order No. 46 with respect to the identification, preparation of programs of work and implementation of projects using labor-based methods.
- 4.2 Assign at least two (2) labor-based engineers to assist the CLATT, on-call or on-station, in the review of programs of work for labor-based projects submitted by the district/city offices and in the monitoring of project implementation.

- 4.3 Identify at least two (2) projects for demonstration purposes and assist in the conduct of labor-based training courses along with the implementation of the demonstration projects.
- 4.4 Provide technical assistance and guidance to the district/city offices under them in the programming, implementation and management of labor-based projects.

5. District/City Offices

- 5.1 Ensure that all personnel who have undergone or will undergo training in labor-based methods are fully utilized in the programming, supervision and management of labor-based programs and projects.
- 5.2 Initiate/undertake programs of labor-based construction and maintenance, especially for small, community-type projects, on a continuing annual and long-term basis.
- 5.3 Ensure local community participation in the implementation of labor-based projects.
- 5.4 Monitor the implementation of labor-based projects and submit problems encountered, findings and recommendations to the Planning Service for immediate referral to the proper office(s).

This Order takes effect immediately.
