Pursuant to the provisions of Republic Act No. 9184 or the Government Procurement Reform Act and its Implementing Rules and Regulations (IRR), and to facilitate better coordination, flexibility and efficiency in the procurement process for the Urgent Bridges Construction Project Rural Development (UBCPRD), a special Bids and Awards Committee (BAC) for UBCPRD is hereby created as follows:

The functions of the BAC for UBCPRD shall be in accordance with the relevant provisions of Republic Act 9184.

The regular members of the BAC for UBCPRD shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Secretary. In cases of resignation, retirement, separation, transfer, re-assignment, removal, or death, the replacement shall serve only the unexpired term.

The following shall be invited as observers, who shall sit in and monitor proceedings of the BAC for UBCPRD as non-voting members:

- One (1) Representative from the Commission on Audit (COA);
- One (1) Representative from the Philippine Constructors Association (PCA) or the National Constructors Association of the Philippines (NACAP) or any association recognized by the Construction Industry Association of the Philippines (CIAP)
- One (1) Representative from an end-user or a non-governmental organization (NGO).

The BAC for UBCPRD shall be assisted by the existing Secretariat that shall have the functions and responsibilities prescribed in R.A. 9184 and its IRR and perform other such functions as may be directed by the Chairman. The head of the Secretariat shall sit as a non-voting member of the said BAC.

Any and all Department Orders and other issuances inconsistent herewith are hereby repealed accordingly.

This order takes effect immediately.
