In the exigency of the service and pursuant to Administrative Order No. 43, "CREATING A TRANSITION COMMITTEE AND INTERNAL TRANSITION COMMITTEES IN DEPARTMENTS AND AGENCIES IN THE EXECUTIVE BRANCH," there is hereby created a DPWH Transition Committee which shall initiate and oversee activities that shall ensure the continuity of government programs and projects. It shall formulate and implement a transition plan to include:

1. Preparation of Transition Report;
2. Establishment of systems and procedures for transition to ensure continue operations;
3. Facilitate and coordinate resolution of issues that may arise at the preparation and implementation of activities related to the transition;
4. Oversee turnover activities;
5. Conduct briefings for incoming officials; and
6. Extend technical and administrative assistance to the Head of Office and his/her staff.

Specifically, the Transition Committee shall prepare reports on the following:

1. Completed, on-going, and proposed projects under the Build Build Build, Public-Private Partnership, Convergence, Flood Control, and Bridge programs, and other major local projects funded under the General Appropriation, including airports and by-pass roads.
2. Construction of Covid-19 emergency facilities, and reconstruction/repairs of damaged infrastructure, including public buildings, as a result of typhoons Odette and Agaton, and the siege in Marawi.
3. Status of major infrastructure projects in the CAR, BARMM, and Region VIII.
4. Completed and on-going foreign funded infrastructure projects;
5. Completed and on-going feasibility studies for major projects either funded through foreign loans or grants.

The undersigned shall act as Chairman of the said Committee, and Senior Undersecretary Rafael C. Yabut as Vice Chairman.

The following are hereby designated as members of the Transition Committee:

1. Undersecretary Ardeliza R. Medenilla
2. Undersecretary Emil K. Sadain
3. Acting Undersecretary Constante A. Llanes
4. Assistant Secretary Marichu A. Palafox.

Undersecretary Emerson L. Benitez is hereby designated as Head of the Secretariat of the Transition Committee. He shall keep records of the proceedings of the Transition Committee and submit reports of said proceedings to the Chairman. He shall be assisted by Director Michael S. Villafranca on matters related to support services, and NCR Regional Director Nomer Abel P. Canlas with respect to the physical arrangements of the Presidential Inauguration.

All reports of the Transition Committee shall be coursed through the Chairman who shall in turn directly report to the Presidential Transition Committee.

This Order takes effect immediately.

**CREATING A PRESIDENTIAL TRANSITION COMMITTEE AND
INTERNAL TRANSITION COMMITTEES IN DEPARTMENTS AND
AGENCIES IN THE EXECUTIVE BRANCH**

WHEREAS, it is the policy of the government to undertake all reasonable measures to ensure a peaceful, orderly and smooth transfer of powers to the next duly-elected President;

WHEREAS, the duly-elected President and his incoming Cabinet members should be given full support and cooperation by the outgoing Cabinet to facilitate their assumption into office; and

WHEREAS, there is a need to create a Transition Committee that will work closely with the representatives of the President-elect to ensure a proper and orderly transition of government into the next Administration;

NOW, THEREFORE, I, RODRIGO ROA DUTERTE, President of the Philippines, by virtue of the powers vested in me by the Constitution and existing laws, do hereby order:

SECTION 1. Creation of the Presidential Transition Committee. There is hereby created a Presidential Transition Committee (PTC) which shall assist and support the transition efforts of the President:

Chairperson : Executive Secretary

Members : Secretary, National Economic and Development
Authority

Secretary, Department of Budget and Management

Secretary, Department of Finance

Secretary, Department of Foreign Affairs

The Office of the Cabinet Secretariat and the Presidential Management Staff shall jointly provide technical and secretariat support to the PTC.

THE PRESIDENT OF THE PHILIPPINES

SECTION 2. Functions of the PTC. The PTC shall have the following functions:

- a. Serve as the overall and central coordination committee of all executive departments, agencies, bureaus, government-owned or -controlled corporations and other instrumentalities of the government relative to the transition to the new Administration;
- b. Oversee the preparation and implementation of the respective transition activities of all government agencies, to ensure continuity and maintain the efficiency of government services; and
- c. Perform such other functions as the President may direct.

SECTION 3. Creation of Internal Transition Committees. All departments, agencies, bureaus, offices and other instrumentalities of the government shall constitute their respective internal transition committees within five (5) days from the effectivity of this Order. The composition of the internal transition committees shall be determined by the said government agencies based on their respective organizational structure and transition requirements.

The internal transition committees shall oversee the formulation and implementation of systems and procedures for transition, to ensure continued operations of their respective departments during the transition period.

SECTION 4. Effectivity. This Order shall take effect immediately.
