SUBJECT: INTEGRATING THE MPR-PMO WITH THE  
REGIONAL (R-III) OFFICE AND  
DEFINING LEVELS OF AUTHORITIES  
IN THE IMPLEMENTATION OF PROJECTS  
UNDER THE MT. PINATUBO REHABILITATION  
PROGRAM

In the interest of the service, the MPR-PMO is hereby integrated with the Regional (R-III) Office and the following levels of authorities pertaining to the implementation of projects under the Mt. Pinatubo Rehabilitation Program are hereby prescribed:

5) Approval of extension of contract time or suspension of work for contracts under Item 3 above not exceeding cumulative change of 25% of original contract time provided that no single extension or suspension shall exceed

6) Approval of vouchers and countersigning of checks for payment of claims for contracts/projects under Item 3 above payable at the District/City/Regional Office. Signing of checks shall be done by the following officials:

Provided that where project funds are fully released to the Regional Office, there shall be no limit on the amount of voucher to be approved by the Program Director and his countersigning checks therefor, and the amount of check to be signed by the Regional Director pertaining to vouchers approved by the Program Director.

Note: Payments of claims for contracts/projects under Project Manager's (Pointmen) shall be paid at the District Office.

7) a) Approval of deeds of sale of Right-of-Way lots/sites acquired by the Regional Office or the District/City engineering offices.

a) Not exceeding P100,000 per claim. Payment voucher shall be approved by DE/CE. Checks to be signed by ADE/ACE and countersigned by DE/CE.

b) Approval of agreements to demolish improvements thereon regardless of cost.

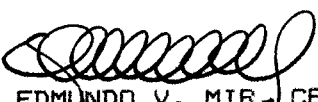
