SUBJECT: CREATION OF THE NEGROS
OCCIDENTAL 3RD ENGINEERING
DISTRICT OFFICE AND RESTRUCTURING
OF NEGROS OCCIDENTAL 1ST AND
2ND ENGINEERING DISTRICT OFFICES

Pursuant to Sections 6 and 25 of Executive Order No. 124 dated 30 January 1987, and as allowed by the Department of Budget and Management, the Negros Occidental 3rd Engineering District is hereby created in Region VI, with the following component Municipalities in the Province of Negros Occidental:

The Negros Occidental 3rd Engineering District Office shall have its headquarters in the Municipality of Kabankalan, and shall operate in the meantime as a 3rd Class Engineering District Office with a personnel complement of 61 regular positions in accordance with the approved Organization, Staffing and Classification Action Summary (OSCAS).

The areas of responsibility of Negros Occidental 1st Engineering District Office and the Negros Occidental 2nd Engineering District Office are restructured. They shall have jurisdiction over the following Municipalities:

Pending approval of the plantilla and appointments of personnel, the Negros Occidental 3rd Engineering District



shall be manned by employees detailed from the Regional Office and the Negros Occidental 1st and 2nd Engineering District Offices. Salaries of personnel and Maintenance and Other Operating Expenses (MOOE) shall be sourced from current savings, which will be released in due time.

Construction and maintenance equipment, and other resources of the Negros Occidental 1st and 2nd District Engineering Offices shall be temporarily shared with the Negros Occidental 3rd Engineering District Office, in accordance with the needs of each District Office as may be determined by the Regional Director of Region VI.

The Regional Director shall issue the complementary Directives to implement this Order.

This Department Order shall take effect immediately.
