CREATION OF THE SOUTH
COTABATO 2ND ENGINEERING
DISTRICT OFFICE

Pursuant to Sections 6 and 25 of Executive Order No. 124 dated 30 January 1987, and as allowed by the Department of Budget and Management, the South Cotabato 2nd Engineering District is hereby created in Region XII, with the following component Municipalities in the Province of South Cotabato:

The South Cotabato 2nd Engineering District Office shall have its headquarters in the City of General Santos and shall operate in the meantime as a 3rd Class Engineering District Office, with a personnel complement of 61 positions in accordance with the approved Organization, Staffing and Classification Action Summary (OSCAS).

The creation of the South Cotabato 2nd Engineering District Office will not affect the classification/staffing of the South Cotabato 1st Engineering District Office but its area of operation is restructured. It shall have jurisdiction over the Municipalities in the Province of South Cotabato, which were not placed and are not included in the area of responsibility of the South Cotabato 2nd Engineering District Office, as enumerated above.


Pending approval of the plantilla and appointments of personnel, the South Cotabato 2nd Engineering District shall be manned by employees detailed from the Regional Office and the South Cotabato 1st Engineering Office. Salaries of personnel and Maintenance and Other Operating Expenses (MOOE) shall be sourced from current savings which will be released in due time.

Construction and maintenance equipment, and other resources of the South Cotabato 1st District Engineering Office shall be temporarily shared with the South Cotabato 2nd Engineering District Office, in accordance with the needs of each District Office as may be determined by the

Regional Director of Region XII.

The Regional Director shall issue the complementary Directives to implement this Order.

This Department Order shall take effect immediately.
