DEPARTMENT ORDER

SUBJECT: CREATION OF THE ILOCOS SUR 2ND ENGINEERING DISTRICT OFFICE AND RESTRUCTURING OF THE ILOCOS SUR 1ST ENGINEERING DISTRICT OFFICE

Pursuant to Sections 6 and 25 of Executive Order No. 124 dated 30 January 1987, and as allowed by the Department of Budget and Management, the Ilocos Sur 2nd Engineering District is hereby created in Region I, with the following component Municipalities in the Province of Ilocos Sur:

12. Salcedo 1. Alilem 2. Banayoyo 13. San Emilio 14. San Esteban 3. Burgos 15. Santa Cruz 4. Candon 16. Santa Lucia 5. Cervantes 17. Santa Maria 6. Galimuyod 18. Santiago 7. Gregorio del Pilar 19. Suyo 20. Tagudin 21. Sigay 8. Lidlidda 9. Nagbukel 10. Narvacan 11. Ouirino 22. Sugpon

The Ilocos Sur 2nd Engineering District Office shall have its headquarters in the Municipality of Candon, and shall operate, in the meantime as a 3rd Class Engineering District Office with a personnel complement of 61 positions in accordance with the approved Organization, Staffing and Classification Action Summary (OSCAS).

The Ilocos Sur Engineering District is restructured from 1st Class to 2nd Class Engineering District Office in accordance with the approved OSCAS. It shall maintain its present headquarters, and shall comprise the following Municipalities of Ilocos Sur:

- 1. Bantay
- 2. Cabugao
- 3. Caoayan
- 4. Magsingal
- 5. San Ildefonso
- 6. San Juan

- 7. San Vicente
- 8. Santa Catalina
- 9. Santo Domingo
- 10. Sinait
- 11. Vigan

Pending approval of the plantilla and appointments of personnel, the Ilocos Sur 2nd Engineering District Office shall be manned by employees detailed from the Regional Office and the Ilocos Sur 1st Engineering District Office. Salaries of personnel and Maintenance and Other Operating Expenses (MOOE) shall be sourced from current savings, which shall be released in due time.

Construction and maintenance equipment, and other resources of the Ilocos Sur 1st District Engineering Office shall be temporarily shared with the Ilocos Sur 2nd Engineering District Office, in accordance with the needs of each District Office as may be determined by the Regional Director of Region I.

The Regional Director shall issue the complementary Directives to implement this Order.

This Department Order shall take effect immediately.
