DEPARTMENT ORDER) SUBJECT: AMENDING THE AUTHORITIES AND RESPONSIBILITIES OF AREAS OF **DPWH UNDERSECRETARIES AND** ASSISTANT SECRETARIES

In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended, as follows:

Undersecretary MANUEL M. **BONOAN**

shall have overall supervision and control of the Service (PS) and Project Management Planning Offices (PMOs) performing planning-related functions. He shall likewise be the Co-Chairman of the Central Office Bids and Awards Committee (BAC) for Consultancy Services. He shall continue to be the Project Implementation Officer for **ODA**-assisted projects implemented by the Department.

Undersecretary BASHIR D. RASUMAN -

shall have overall supervision and control of the Project Management Offices. He shall serve as the Chairman of the BAC for PMO projects and Co-Chairman of the Central Office BAC for Consultancy Services.

Undersecretary ANTONIO A.

INOCENTES shall have overall supervision and control of the Administrative and Manpower Management Service and the Legal Service.

Assistant Secretary MANUEL S. **AGYAO**

shall have overall supervision and control of the operations (for region/district-implemented projects) for Regions I, II, III, IV-A, IV-B and CAR, and the Internal Audit Service and the Bureau of Maintenance (BOM). For this purpose, he shall be reporting directly to the Secretary. He shall serve as Chairman of the BAC in his area of responsibility.

Assistant Secretary RAUL C.

ASIS

shall have overall supervision and control of the Monitoring and Information Service (MIS) and the Bureau of Research and Standards (BRS). He shall also serve as for Project Assistant Secretary Monitoring. For this purpose, he shall be reporting directly to the Secretary. In addition, he shall assist Undersecretary Bonoan as Assistant Secretary in the Planning Service (PS) and PMOs performing planning-He shall, likewise. related functions. Undersecretary Inocentes as Assistant Secretary in the Administrative and Manpower Management Service (AMMS).

Assistant Secretary MOCAMAD M. RAKI-IN, SR. -

shall have overall supervision and control of the operations (for region/district-implemented projects) for Regions IX, X, XI, XII, and XIII, and the Bureau of Construction (BOC) and the Bureau of Design (BOD). For this purpose, he shall be reporting directly to the Secretary. He shall serve as Chairman of the BAC in his area of responsibility.

Assistant Secretary RAFAEL C. YABUT -

shall have overall supervision and control of the operations (for region/district-implemented projects) for Regions V, VI, VII, VIII and the NCR, and the Comptrollership and Financial Management Service (CFMS) and the Bureau of Equipment (BOE). For this purpose, he shall be reporting directly to the Secretary. He shall serve as the Chairman of the BAC in his area of responsibility.

The above-mentioned authorities and functions shall be performed in accordance with the provisions of Department Order No. 42, series of 1988, as amended and other pertinent issuances.

This order shall take effect immediately, and all other orders, circulars, and memoranda inconsistent herewith are hereby modified and/or revoked accordingly.
