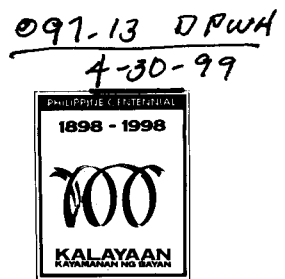

In the interest of the service and pursuant to Memorandum dated 16 January 1996, Re: Organization of Specialized Environmental Impact Assessment (EIA) Group, it is hereby directed that all existing staff from the PMO's and the Planning Service who are presently detailed at the EIAPO since January 1996 shall be retained during the entire duration of the project.
