

In line with the policy of the Department to promote transparency in its operations and pursuant to pertinent provisions of Memo Circular No. 79 of the Office of the President dated October 12, 1988 amending the implementing rules and regulations of P.D. 1594, each FBAC shall have a representative from at least one of the following organizations who shall be a non-voting member:

1. Philippine Institute of Civil Engineers

2. Philippine Constructors Association

3. National Confederation of Contractors Association of the Philippines, Inc.

4. Philippine Institute of Certified Public Accountants

Pursuant to existing rules and regulations, a representative shall be invited as witness in every proceeding.

The PBAC shall be responsible for the prequalification of prospective bidders/suppliers, bidding/canvass, evaluation of bids/canvass and awards for those within their respective areas of jurisdiction as indicated herein. The Chairman of each PBAC is authorized to sign Invitation to Bid for those within his area of concern and approve correspondingly Resolutions for Prequalification and Resolution of Awards not exceeding the amount of P10,000,000.00 in each case.

The PEVAC for Consultancy shall be responsible for the conduct of prequalification of consultants, evaluation proposals, selection and recommendation of award of contracts. The PEVAC Chairman is authorized to sign Invitation for Consulting Services and Approve Resolutions for Selection and Award of Consulting Services not exceeding P1,000,000.00.

The Central PBAC Secretariat shall serve as the technical support staff and shall be responsible in the safekeeping of pertinent records of the above Committees. The Secretariat, thru the PBAC Chairman concerned, is hereby authorized to seek the technical assistance of and/or detail of personnel from various offices of the Department in relation to their assigned tasks.

This Order takes effect immediately and all other orders, circulars, and memoranda inconsistent herewith are hereby modified and/or revoked accordingly.
