DEPARTMENT ORDER) SUBJECT: Amendment of Department Order  
No. **130** <sup>72</sup> <sub>5/31</sub> No. 55, s. of 1991, re: assignments  
Series of 1991 of Undersecretaries

In view of the resignation of Undersecretary Jose F. Mabanta effective 31 May 1991, Department Order No. 55 dated 21 February 1991, is hereby amended as follows:

1. Field Operations are hereby divided into the following three groups:
  - a. Field Operations "A" (FOA) covering Regions I, II, III and Cordillera Administrative Region.
  - b. Field Operations "B" (FOB) covering the National Capital Region and Regions IV-A and IV-B.
  - c. Field Operations "C" (FOC) covering Regions V, VI, VII, VIII, IX, X, XI, and XII.
2. Assignment of Undersecretaries
  - a. Undersecretary Edmundo V. Mir
    - (1) Undersecretary for FOA.
    - (2) Undersecretary for Allied Services related to Foreign-assisted Projects with administrative and technical supervision over all Central Office Project Management Offices.
    - (3) Chairman, Central Office Prequalification, Bidding and Awards Committees (PBACs) for civil works and for construction equipment/materials/supplies contracts of projects under FOA.
    - (4) Chairman, Central Office Prequalification, Evaluation and Awards Committee (PEACs) for consulting services for projects under FOA.
  - b. Undersecretary Teodoro T. Encarnacion
    - (1) Undersecretary for FOB.
    - (2) Undersecretary for Technical Support Services with administrative and technical supervision over the Planning Service and the Bureaus of Design, Construction, Maintenance, Research and Standards, and Equipment.

- (3) Chairman, Central Office PBACs for civil works and construction equipment/materials/supplies contracts of projects in FOB.
- (4) Chairman, Central Office (PEAC) for consulting services for projects under FOB.
- c. Undersecretary Romulo M. del Rosario
  - (1) Undersecretary for Field Operations "C" (FOC).
  - (2) Chairman, Central Office PBACs for civil works and for construction equipment/materials/supplies contracts of projects under FOC.
  - (3) Chairman, Central Office PEAC for consulting services of projects under FOC.
- d. Undersecretary Gregorio S. Alvarez
  - (1) Undersecretary for Administrative and Financial Support Services, with administrative and technical supervision over the Administrative and Manpower Management Service, Comptrollership and Financial Management Service, Legal Service, Internal Audit Service, and Monitoring and Information Service.
  - (2) Chairman, Central Office PBAC for Office equipment/materials/supplies contracts.

This Order shall supersede all Department Orders, memoranda and other issuances or portions thereof which are inconsistent with it. Other provisions of Department Order No. 55, dated 21 February 1991, not inconsistent with this Order shall, however, remain to be effective.

This Order shall take effect on 01 June 1991.
