The Task Force shall perform the following tasks and functions:

Task Force Leader	<ul style="list-style-type: none"> - Shall provide overall management and guidance in the project monitoring during the implementation from the detailed engineering, pre-construction and construction stages. - Shall be responsible in providing monthly updated status/information on the project implementation to the Secretary. - Shall be responsible in coordinating with other concerned government agencies and other stakeholders for issues and concern in the project implementation.
Assistant Task Force Leader	<ul style="list-style-type: none"> - Shall assist the Task Force Leader in the overall management and guidance in the project monitoring during the implementation from the detailed engineering, pre-construction and construction stages. - Shall act as the over-all field coordinator and monitoring during the project implementation.
Project Monitoring Manager	<ul style="list-style-type: none"> - Shall oversee the monitoring activities of the three (3) Cluster Teams. - Coordinate with the implementing office, LGU concerned, and other stakeholders for any issues and concern that affects project implementation. - Review/consolidate monthly status reports for each project submitted by the Cluster Team Leader and submit to the Task Force Leader thru the Assistant Task Force Leader. - Review/consolidate monthly status reports for each project submitted by the Cluster Team Leader and submit to the Task Force Leader thru the Assistant Task Force Leader. - Coordinate with the implementing office/other offices concerned to facilitate the preparation of plans and programs, release of funding allocation and its implementation to ensure timely project implementation and completion.

Cluster Team Leader	<ul style="list-style-type: none"> - Supervise/oversee its cluster members in the conduct of regular monitoring activities during the project implementation. - Collect/review/consolidate monthly status reports for each project and submit to the Project Manager. - Evaluate the performance of the implementing office, initiate/recommend appropriate measures for issues and concern that needs to be addressed.
Team Members	<ul style="list-style-type: none"> - Conduct regular field monitoring on the progress and development of the implementation of various reconstruction and rehabilitation projects in areas affected by Typhoon Yolanda. - Submit Monthly Reports on the Physical and Financial Status to the Cluster Team Leader, including issues and concerns that need to be addressed. - Determine/Identify issues and concern that affected or will affect the project implementation, recommend appropriate action in coordination with the concerned parties/stakeholders.
Office of the Presidential Assistant for Rehabilitation and Recovery (OPARR) Coordinator	<ul style="list-style-type: none"> - Coordinate with the different implementing agencies on the status of the projects. - Consolidate the monthly status reports of all the implementing agencies for submission to the Secretary.

In addition, the team shall recommend courses of action and implement strategies to fast-track the completion and to ensure successful project implementation.

All concerned Implementing Offices shall extend full support and cooperation to the Task Force in order to ensure completion of Funded Projects by June 2015.

This Order shall take effect immediately.
