**SUBJECT : Amendment to D.O. No. 229, s. of 1991
Regarding the Guidelines in the Advertisement
of Infrastructure Projects**

It has been observed that some implementing offices, (Regional Offices, District/Sub-District Engineering Offices and Project Management Offices) do not completely follow the guidelines of the publication of advertisement of infrastructure projects prescribed in Department Order No. 229, series of 1991. For uniformity and economy in advertising infrastructure projects, the following guidelines are hereby reiterated:

1. For uniformity, all project implementing offices shall cause all advertisements of **"Invitation for Prequalification/Eligibility of Bidders"** for infrastructure projects to adopt the attached standard format.
2. The advertisement shall contain, among other things, the approved budget for the contract, the estimated date of commencement of work, and the period within which the contract work should be finished. The equipment requirement shall not be included in the advertisement.
3. To save on advertisement cost, several projects may be clustered in one advertisement. The classified display should not exceed three (3) columns by twenty five (25) centimeters. Short advertisements should be contained in smaller sizes.

This Order shall take effect immediately.

Contractor's Prequalification/Eligibility Statement Forms and Bid Documents may be obtained from the PBAC upon payment of a non-refundable fee of P_____.

All particulars relative to Prequalification/Eligibility, Bid Bond, Performance Bond, Pre-Bid Conference, Bid Evaluation and Award of Contract shall be governed by the provisions of P.D. 1594 and its Implementing Rules and Regulations, as amended, and other applicable rules and regulations.

The Government reserves the right to reject any or all bids, waive any minor defect therein, and accept the offer most advantageous to the Government.
