DEPARTMENT ORDER

SUBJECT: RECONSTITUTING THE BUILDING
RESEARCH AND DEVELOPMENT
STAFF (BRDS).

Pursuant to Section 202 of P.D. 1096 otherwise known as the National Building Code of the Philippines, authorizing the Secretary of Public Works and Highways to organize a professional staff to assist in the administration and enforcement of the provisions of the National Building Code and its implementing rules and regulations, the Building Research and Development Staff (BRDS) is hereby reconstituted and its functions reiterated as follows:

1. Assist the Secretary in the management and supervision of the activities of Building Official in the implementation of the Code.
2. Assist the Bureau of Research & Standards (BRS) in developing, formulating or amending rules and regulations and reviewing referral codes for possible amendments, for the effective implementation of the National Building Code.
3. Review, evaluate and take final action on various technical and legal problems forwarded to the Office of the Secretary for resolution.
4. Assist the Administrative and Manpower Management Service in the conduct of National Building Code Seminars and that B.P. 344 (Accessibility Law).
5. Coordinate with all concerned agencies, organizations and individuals in the implementation of the above functions.
6. Undertake such other duties and tasks as may be assigned by the Secretary from time to time.

The Staff shall be under the overall management and supervision of an Executive Director who shall direct its operation within the scope envisioned in Section 202 of P.D. 1096 and the NBC Memorandum Order No. 77-1 and as authorized by the Secretary and shall be composed of the following:


