In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended as follows:

Undersecretary EDMUNDO V. MIR

- shall have overall supervision and control of the Bureau of Construction, Bureau of Maintenance, Bureau of Equipment, and Public Information Office, and such other special projects as may be assigned by the Secretary.

Undersecretary TEODORO T. ENCARNACION - shall have overall supervision and control of the Planning Service, Monitoring and Information Service, Bureau of Design, Bureau of Research and Standards, and Legislative Liaison Office, and such other special projects as may be assigned by the Secretary.

Undersecretary MABINI F. PABLO

Undersecretary MANUEL M. BONOAN

Assistant Secretary JESUS P. CAMMAYO

- shall have overall supervision and control of the Administrative and Manpower Management Service. Comptrollership and Financial Management Service, and Legal Service, and such other special projects as may be assigned by the Secretary.
- shall have overall supervision and control of field operations covering all infrastructure projects and activities, including foreign assisted projects, in the National Capital Region, Regions IV-B, V, VI, VII, and VIII, and such other special projects as may be assigned by the Secretary.
 - shall have overall supervision and control of field operations covering all infrastructure projects and activities, including foreign assisted projects, in Regions I, II, III and IV-A, and the Cordillera Administrative Region, and other special projects as may be assigned by the Secretary.

Assistant Secretary JOSE H. ESPIRITU

- shall have overall supervision and control of field operations covering all infrastructure projects and activities, including foreign assisted projects, in Regions IX, X, XI, XII and XIII, and other special projects as may be assigned by the Secretary.

- shall have direct supervision and control over the Administrative and Manpower Management Service, Bids and Awards Committee – Technical Working Group, and other special projects as may be assigned by the Secretary, and shall act as Chairman of the Pre-Qualification, Evaluation and Awards Committee (PEAC).
- shall have direct supervision and control over the Comptrollership and Financial Management Service, Legal Service, and other special projects as may be assigned by the Secretary, and shall act as Chairman of the Bids and Awards Committee (BAC).

The Internal Audit Service shall be directly under the Secretary.

The above-mentioned authorities and functions shall be performed in accordance with the provisions of Department Order No. 42, series of 1988, as amended, and other pertinent issuances.

This Order shall take effect immediately, and all other orders, circulars and memoranda or parts thereof inconsistent herewith are hereby revoked and/or modified accordingly.
