SUBJECT: Creation of an Additional Engineering District, and Reconstitution and Renaming of the Quezon 1st and 2nd Engineering Districts, in the Province of Quezon

Pursuant to Sections 6 and 25 of Executive Order No. 124 dated 30 January 1987, and as authorized under Republic Act No. 6831, otherwise known as the General Appropriations Act for FY 1990, an additional Engineering District Office in the Province of Quezon is hereby created, to be known as the Quezon 1st Engineering District Office. The existing Quezon 1st Engineering District Office and Quezon 2nd Engineering District Office are hereby reconstituted and renamed Quezon 2nd Engineering District Office and Quezon 3rd Engineering District Office, respectively.

The new Quezon 1st Engineering District Office shall have its headquarters at the Municipality of Mauban.

The reconstituted Quezon 2nd Engineering District Office shall have its headquarters at Lucena City, with Sub-District Office at the Municipality of Gumaca, and the reconstituted Quezon 3rd Engineering District Office shall maintain its headquarter at the Municipality of Catanaun.

The areas of responsibility of the three Engineering District Offices shall be as follows:
