AND 2ND ENGINEERING DISTRICT

Pursuant to Sections 6 and 25 of Executive Order No. 124 dated 30 January 1987, and as authorized under RA 6831, General Appropriations Act for FY 1990, the Leyte 3rd Engineering District Office is hereby created in Region VIII, with the following component municipalities in the Province of Leyte:


