Interest" Form to be used
by Bidders

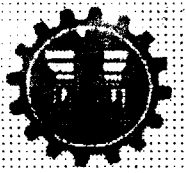
It has been observed that most registered DPWH Contractors update their Contractors' Information Record in the DPWH Registry only on their newly completed projects, financial status and license. No contractor has ever updated information on the status of his on-going contracts nor even those that were awarded but not yet started. In this regard, Form NR 003 is hereby revised incorporating the above mentioned requirement to be filled up by every contractor in submitting Expressions of Interest.

Likewise, contractors who intend to submit Expressions of Interest (Form NR 003) for a particular project directly to the Central BAC-TWG Office has to attach a copy of the original or certified true copy of the newspaper advertisement.

Additionally, in accordance with Department Order No. 176, Series of 1993, only the owner or the authorized representative of the contractor as reflected in the DPWH Registry will be allowed to transact business relative to bidding matters of the Department.

This order supersedes previous issuances to the contrary and shall take effect immediately.
