SUBJECT: Creation of the Build Build Build (BBB) Committee

In line with the Department's efforts to efficiently and effectively participate in the government's infrastructure program entitled "Build Build Build" (BBB), a committee on BBB is hereby created, which shall be under the supervision of the Undersecretary for Legal Affairs and Priority Projects.

A. Composition. The BBB Committee shall be composed of the following:

1. Committee Head: Anna Mae Y. Lamentillo, or a person designated by the Secretary in case of a vacancy.
2. Committee Members:
 - a. The Directors of the:
 - i. Information Management Service
 - ii. Public-Private Partnership Service
 - iii. Stakeholders Relations Service
 - b. All Project Directors of Unified Project Management Offices
 - c. All Regional Directors.

B. Functions. The BBB Committee shall be responsible for coordinating with other government agencies, including the National Economic Development Authority, the Department of Transportation, and the Bases Conversion and Development Authority, on all matters related to the BBB program. Each member of the BBB Committee shall, in all matters covered by the functions of his/her office and in connection with projects identified by the Committee Head as part of the BBB program (BBB Projects):

1. Provide technical information and assistance;
2. Supervise the creation of project briefs;
3. Provide relevant maps, images, detailed designs, and other documents;
4. Assume full accountability with regard to the collection, storage, dissemination and accuracy of data and information;
5. Regularly provide updates on any progress and development; and
6. Gather relevant news articles, media reports, and other items related to BBB Projects.


C. BBB Technical Sub-Committee. To support the functions of the BBB Committee, a BBB Technical Sub-Committee is hereby created.

1. Each BBB Committee Member shall assign one (1) contact person to directly coordinate, report to, and work with the Committee Head for the preparation of any

data, document, information, report and content required by the BBB program and/or related to the BBB Projects.

2. The Director of Stakeholders Relations Service shall designate four (4) persons to carry out the tasks of preparing data/information in the format required by the BBB program and/or the BBB online portal. Such designated persons shall report directly to the BBB Committee Head for purposes of carrying out such tasks.
3. The Director of Information Management Service shall designate three (3) persons to carry out the tasks of technical programming, uploading to the BBB online portal, and archiving/retrieval of data/information related to the BBB program. Such designated persons shall report directly to the BBB Committee Head for purposes of carrying out such tasks.

This Department Order shall take effect immediately and supersedes all previous Department Orders to the contrary.
