SUBJECT : PRESCRIBING NEWSPAPERS

FOR ADVERTISEMENT AMENDING  
DEPARTMENT ORDER NO. 79,  
SERIES OF 2000

In accordance with the provisions of the Implementing Rules and Regulations of E.O. No. 40, series of 2001, the Invitation to Apply for Eligibility and to Bid for contracts with an Approved Budget for the Contract (ABC) costing two million pesos (P2,000,000.00) and above for the procurement of Goods, five million pesos (P5,000,000.00) and above for the procurement of civil works, and five hundred thousand pesos (P500,000.00) and above for consultancy services shall be advertised at least twice within a minimum period of two (2) consecutive weeks, with a period of seven (7) calendar days between publications, in at least two (2) newspapers of general nationwide circulation which have been regularly published for at least two (2) years before the date of issue of the advertisement. This requirement is in addition to the required posting in the DPWH Website and in the Electronic Procurement System (EPS) and in conspicuous places in the premises of the office concerned.

All advertisements of the Department, including those of the Regional, District and Sub-District Offices for Invitations to Apply for Eligibility and to Bid in the Procurement of civil works, consultancy services and goods and related services shall be advertised in the two (2) newspapers of general circulation which were selected through public bidding as per approved resolution of the Bids and Awards Committee (BAC) for Office Supplies, Materials, Equipment and Services dated 13 February 2002. The advertisements shall be published in the two (2) newspapers enumerated herein for a period of one (1) year from the date of this Order, unless otherwise directed by the Secretary.

The two (2) newspapers of general nationwide circulation with their corresponding prescribed rates are as follows:
