SUBJECT: **AMENDING THE AUTHORITIES AND  
AREAS OF RESPONSIBILITIES OF DPWH  
ASSISTANT SECRETARIES**

In the interest of the service and pursuant to Sections 6 and 37 of Executive Order No. 124 dated 30 January 1987, the authorities and areas of responsibilities of Undersecretaries and Assistant Secretaries are hereby amended as follows:

Assistant Secretary MANUEL S.  
AGYAO

- shall have overall supervision and control of the Operations for Regions I, II and CAR. He shall retain supervision and control of the Bureau of Maintenance (BOM), as well as, the Chairmanship of the BAC for Construction/Maintenance Materials and Equipment. For this purpose, he shall be reporting directly to the Secretary.

Assistant Secretary RAUL C. ASIS

- shall have overall supervision and control of the Bureau of Construction (BOC), Bureau of Design (BOD), and Bureau of Research and Standards (BRS) and retain supervision and control of the Administrative and Manpower Management Service (AMMS). For this purpose, he shall be reporting directly to the Secretary. In addition, he shall assist Undersecretary Bonoan as Assistant Secretary in the Planning Service (PS), Monitoring and Information Service (MIS), PMOs performing planning-related functions, and in the overall administrative supervision over all PMOs performing civil works functions.

Assistant Secretary MOCAMAD M.  
RAKI-IN, SR.

- shall have overall supervision and control of the Operations for Regions VI, VII and VIII and the Bureau of Equipment (BOE). He shall retain the Chairmanship of the BAC for Office Supplies and Equipment. For this purpose he shall be reporting directly to the Secretary.

Assistant Secretary RAFAEL C.  
YABUT

- shall continue to have overall supervision and control of the Operations for Regions III, IV-A, IV-B, V and the NCR, as well as, the Chairmanship of the Bids and Awards Committee (BAC) in his area of responsibility. In addition, he shall have supervision and control of the Comptrollership and Financial Management Service (CFMS). For this purpose he shall be reporting directly to the Secretary.

The above-mentioned authorities and functions shall be performed in accordance with the provisions of Department Order No. 42, series of 1988, as amended, and other pertinent issuance.

This order shall take effect immediately, and all other orders, circulars, and memoranda inconsistent herewith are hereby modified and/or revoked accordingly.
