SUBJECT: **CREATION OF INTER-AGENCY COMMITTEE FOR THE FORMULATION OF INTER-AGENCY INFRASTRUCTURE MAP**

To ensure the effective and coordinated efforts for the formulation of inter-agency infrastructure map, an Inter-Agency Infrastructure Mapping Committee is hereby created composed of the following:

II. **DPWH Mapping Unit** GIS and RBIA Teams of IPRSD, Planning Service

The **Inter-Agency Coordinator** shall ensure proper and coordinated inter-agency activities and oversee the progress undertaken by the committee until task completion. The **Agency Focal Person** shall provide his/her agency's policy direction, supervise the preparation and approve the contents and distribution of his/her agency map. The **Agency Coordinator** shall provide the contents and features of his/her agency map and monitor the updating progress of his/her agency mapping activities. **The DPWH Mapping Unit** shall prepare the DPWH GIS shapefiles and databases, shall establish proper coordinates, location and alignment of facilities, shall provide assistance to other agencies (if necessary), and shall prepare and print/reproduce the inter-agency infrastructure map and other documentation.

The following guidelines shall be adopted by the Committee in the preparation and utilization of inter-agency infrastructure map:

1. The NAMRIA scanned topographic maps of scale 1:50,000 shall be the official base map to be utilized in the formulation of GIS-based infrastructure map.

2. Each agency shall provide/produce their own shapefiles/layers with datasets for inclusion in the infrastructure map to be submitted to DPWH and NAMRIA for review and consolidation.
3. Agencies with limited mapping and GIS technical capabilities will be supported/assisted by DPWH and NAMRIA.
4. NAMRIA shall be responsible for the evaluation of inputs and integration of long-term map layers.
5. All map attributes/elements should be provided with proper identification.
6. The infrastructure map shall be presented at maximum 1:50,000 scale as the acceptable margin of error.
7. The infrastructure map, datasets and documentations shall be approved by the Agency Focal Persons before it is presented/published and provided to each agency member.
8. Agency inputs shall be regularly updated and submitted to NAMRIA and DPWH for the annual updating of Inter-Agency Infrastructure Map for presentation in the Senate for budget deliberation.
9. DPWH shall prepare the reports and final outputs.

The Committee shall hold regular meetings and coordination and shall, as the need arises, update the agency inputs to further enhance the features of the inter-agency infrastructure map.

This Order shall take effect immediately.
