The Negotiation shall cover the following:

3. Reasonable Rate of Return;
4. Terms and Conditions of the Concession Agreement.


The Negotiating Team shall be assisted by such offices and advisors as may be necessary to conclude the negotiations within the periods required by law.

Representative/s from other government concerned agencies may be invited to provide assistance during the negotiation, if necessary.

They shall submit the report to the Secretary on or before 28 June 2015 for the Secretary's consideration and if he is amenable, for endorsing it to NEDA. The final result of the negotiation duly signed by the Negotiating Panel shall be the framework of the procurement/Swiss Challenge/tendering to be undertaken by the DPWH SBAC for PPP projects pursuant to SO No. 143 Series of 2014.

The Secretariat shall act as the overall coordinating body between the DPWH, other government stakeholders and the Project Proponent and shall keep a complete record of the negotiations to include minutes of meetings, communications and drafts and final versions of all documents.

This Order shall take effect immediately.
