- 1. To attend to and prepare the necessary designs, lay-out, plans for the physical constructs required by the liturgical and religious assemblies presenced by the Holy Father.
- 2. To coordinate with the Committees and/or Ecclesiastical Authorities concerned, inclusive of requesting the national and/or local civil officials concerned to finance and put up the structures and sound systems.
- 3. Oversee and supervise the preparation and completion of all construction works that may directly affect traffic, beautification and cleanliness within the vicinity areas.
- 4. Identify all the necessary activities/programs and submit to the Secretary for fundina.
- 5. Perform periodic monitoring of project implementation.
- 6. Ensure that all projects are completed within the prescribed timeframe or before the schedule of the event.
- 7. The Chairman shall coordinate all DPWH activities related to the preparatory works of the said event.

This Order shall take effect immediately.
