**SUBJECT: Reactivation/Reconstitution
of the National Building Code
Review Committee and its
Board of Consultants**

Pursuant to Section 5 – Review of Existing Laws, Rules and Regulations, Administrative Order (AO) No. 160 dated October 4, 2006, issued by Her Excellency President Gloria Macapagal Arroyo, mandating the DPWH to review the existing laws, rules and regulations and/or issue stricter rules and regulations on the construction and maintenance of billboards, the National Building Code Review Committee (NBCRC) and its Board of Consultants (BoC) that were organized thru Special Order No. 01 dated June 09, 2004 for the purpose of updating/amending the National Building Code of the Philippines (PD 1096) and its Implementing Rules and Regulations (IRR) are hereby reactivated/reconstituted and shall be composed of the following:

This order supersedes previous issuances to the contrary and shall take effect until the completion of the aforesaid activities.
