ROLES AND RESPONSIBILITIES:

Appointed Official

- 1. Ensures that continuity programs are properly resourced:
- 2. Signs off on final plans and policies developed by the Continuity Planning Team;
- 3. Ensures development of strategic continuity vision and overarching policy; and
- 4. Ensures appointment of key continuity personnel and the development of a program budget for adequate facilities, equipment and training.

Senior Leader

- 1. Approves all required continuity plans and programs;
- 2. Notifies appropriate offices and other organizations/agencies upon execution of continuity plans; and
- 3. Supports the work of the Continuity Manager and Coordination Team for their organization, including providing or requesting for the necessary budgetary and other resources to support the continuity program as required.

Continuity Manager

- 1. Coordinates the overall activities of the Continuity Planning Team; and
- 2. Provides an annual summary of planning activities to DPWH Management Committee.

Continuity Coordination Team

- 1. Harmonizes continuity planning activities with policies, plans and initiatives related to critical infrastructure protection;
- 2. Lead the continuity planning;
- 3. Establishes a Multi-Year Program Management Plan designed to achieve continuity objectives;
- 4. Consolidates the continuity input of the Continuity Planning Team and ensures those inputs reflect and support the intent of the overall continuity plan and sustainment of essential functions;
- 5. Develops and maintains the continuity plan;
- 6. Develops and administers a continuity program budget and submits funding requirements to the Head of Agency lead; and
- 7. Serves as an advocate for the continuity program.

Continuity Planning Team

- 1. Provides guidance and support for development of the organization's continuity plan;
- 2. Establishes coordination within their office for ideas and information regarding continuity planning, procedures and resources available;
- 3. Coordinates continuity exercises, documenting post-exercise lessons learned and conducting periodic evaluations of organizational continuity capabilities;
- 4. Understands the role that adjacent jurisdictions and organizations might be expected to play in certain types of emergency conditions and what support those adjacent organizations might provide;
- 5. Understands the limits of their continuity resources and support capabilities;
- 6. Anticipates the point at which adjacent organizational or mutual aid resources will be required; and
- 7. Initiates and leads the development of the Bureau/Service/Office level continuity plan of their office;

The members of the teams shall work cohesively to come up with an updated DPWH Public Service Continuity Plan which shall ensure the continued delivery of all our services to the general public even during an emergency, disaster or any other disruption.

This order shall take effect immediately and shall supersede Special Order 153 Series 2018.




Figure 1. DPWH Continuity Core Team
