SPECIAL ORDER Series of 2017 SUBJECT: CONSTITUTION OF PRE-QUALIFICATION, BIDS AND AWARDS (PBAC) FOR COMMITTEE THE **PROCUREMENT OF CIVIL WORKS AND** CONSULTING SERVICES FOR PPP PROJECTS

A Pre-Qualification Bids and Awards Committee (PBAC) is hereby created for the procurement of PPP related Civil Works and Consulting Services (Feasibility Study, Transaction Advisor and Independent Consultant) to expedite and ensure efficient implementation of PPP Projects. A Technical Working Group (TWG) is also hereby constituted to undertake the preliminary evaluation of the pre-qualification/eligibility documents and bids (Technical and Financial Proposals) and shall submit the results to the aforementioned PBAC for review and recommendation to the Secretary.
