BY THE PRESIDENT OF THE PHILIPPINES

ADMINISTRATIVE ORDER NO. 35

CONSTITUTING AN INTER-AGENCY TASK FORCE FOR THE HOSTING OF THE *FÉDÉRATION INTERNATIONALE DE FOOTBALL ASSOCIATION* (FIFA) FUTSAL WOMEN'S WORLD CUP 2025, AND DIRECTING ALL GOVERNMENT AGENCIES AND INSTRUMENTALITIES, AND ENCOURAGING LOCAL GOVERNMENT UNITS AND THE PRIVATE SECTOR, TO RENDER SUPPORT THERETO

WHEREAS, Section 17, Article II of the Constitution declares it a policy of the State to give priority to education, science and technology, arts, culture, and sports to foster patriotism and nationalism, accelerate social progress, and promote total human liberation and development;

WHEREAS, Section 19, Article XIV of the Constitution provides that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

WHEREAS, the Philippines, through the Philippine Sports Commission (PSC) and the Philippine Football Federation, is set to host the FIFA Futsal Women's World Cup (FFWWC) 2025;

WHEREAS, the hosting of the FFWWC 2025 aims to advance the development of futsal in the country, inspire greater sports engagement among Filipinos, elevate the Philippines' standing in the international sports arena, and generate economic and tourism opportunities through a globally recognized event; and

WHEREAS, the successful hosting of the FFWWC 2025 requires the involvement and support of all concerned government agencies, including government-owned or -controlled corporations (GOCCs), state universities and colleges (SUCs), local government units (LGUs), and the private sector;

NOW, THEREFORE, I, FERDINAND R. MARCOS, JR., President of the Philippines, by virtue of the powers vested in me by the Constitution and existing laws, do hereby order:

- e. Coordinate and collaborate with other departments, bureaus, offices, agencies, and instrumentalities of the government, including GOCCs, such as, among others, the Manila International Airport Authority, Philippine Amusement and Gaming Corporation, Philippine Charity Sweepstakes Office, Philippine Postal Corporation, and the Cultural Center of the Philippines, for the preparation, organization, and hosting of the FFWWC 2025; and
- f. Perform such other functions as may be directed by the President and/or the Executive Secretary.

Section 3. Agency Coordination. Consistent with their respective mandates, all departments, bureaus, offices, agencies and instrumentalities of the government, including GOCCs and SUC, are hereby directed, and LGUs and the private sector are hereby encouraged, to extend full support and assistance to the preparation, organization, and hosting of the FFWWC 2025.

Section 4. Funding. The amounts necessary for the implementation of this Order shall be charged against any available funding of the agencies concerned, subject to existing budgeting, accounting, and auditing laws, rules and regulations.

Section 5. Separability. If any section or part of this Order is declared invalid or unconstitutional, the other sections not otherwise affected shall remain in full force and effect.

Section 6. Repeal. All other issuances, administrative rules and regulations, or parts thereof, which are inconsistent with this Order, are hereby repealed or amended accordingly.

Section 7. Effectivity. This Order shall take effect immediately.
