On 10 January 2022, the FDA released Advisory No.2022-0003 regarding the new office address of FDAC which is located at the FDA Main Office. The transfer was due to a major fire that broke in StarMall Alabang on 08 January 2022. Subsequently, President Ferdinand "Bongbong" Marcos Jr. delegated Dr. Samuel Zacate as the new Director General of the FDA on 03 August 2022.
