To ensure that only qualified and competent field engineers will be assigned to supervise DPWH infrastructure projects, the Accreditation Committee for DPWH and Contractors'/Consultants' Materials Engineers under Department Order No. 09, Series of 2023 and the Accreditation Committees for DPWH and Contractors'/Consultants' Project Engineers under Department Order Nos. 08 and 30, Series of 2021 and 2019, respectively, are hereby reconstituted with the following composition:


Undersecretary for Technical Services	- Chairman
Assistant Secretary for Technical Services	- Vice-Chairman
Director, Bureau of Research and Standards (BRS)	- Member
Director, Bureau of Quality and Safety (BQS)	- Member
Director, Bureau of Construction (BOC)	- Member
Director, Bureau of Design (BOD)	- Member
Project Director, UPMO-Roads Management Cluster I (Bilateral)	- Member
Regional Director, DPWH-National Capital Region (NCR)	- Member

The Committee shall have the following tasks:

1. Formulate the accreditation guidelines and criteria.
2. Evaluate all applications for accreditation in accordance with the prescribed guidelines/criteria.
3. Recommend to the Secretary through the Undersecretary for Technical Services the issuance of Certificate of Accreditation to qualified field engineers.
4. Establish guidelines for periodic evaluation of accredited Field Engineers.
5. Resolve issues and concerns that may arise in relation to the accreditation guidelines and impose appropriate sanctions (as the case may be) against field engineers who have committed violation and infraction of the accreditation guidelines.
6. Conduct meetings or other related activities as the need arises.

The Chairman of the Committee is authorized to organize a Secretariat from the Bureau of Research and Standards (BRS) for Materials Engineers and the Bureau of Quality and Safety (BQS) for Project Engineers to assist the Committee and seek technical assistance and services that are deemed necessary from any office of the Department to effectively and systematically discharge its mandated tasks.

This Order supersedes Department Order Nos. 09, 08 and 30, Series of 2023, 2021 and 2019, respectively, and shall take effect immediately. All other orders, circulars and memoranda inconsistent herewith are hereby modified/revoked accordingly.
