SUBJECT: Issuance of Suspension Order to AFG CONSTRUCTION CORPORATION

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28, Series of 2024, this Suspension Order is hereby issued against **AFG CONSTRUCTION CORPORATION.**

Based on the Approved Consolidated Three (3)-Strike Report, dated May 31, 2025, and posted on the DPWH Intranet on July 1, 2025, this contractor, bearing the PhilGEPS Registration No. 202112-280902-1464039606 and located at Panacan 2, Narra, Palawan, Region IV-B, has incurred three (3) strikes/offenses within a year from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning. While the specific sub-offense categories vary among Implementing Offices (District Engineering Offices) - namely, (i) submission of incomplete, insufficient, or defective documents due to non-inclusion and/or omission of mandatory provisions and statements for the required Bid Forms, and (ii) failure to submit required Bid Forms - all three (3) violations fall under the main strike offense category of "Submission of Patently Insufficient Bid."

AFG CONSTRUCTION CORPORATION is disqualified from participating in any DPWH bidding processes, effective immediately upon receipt of the Notice of Suspension. This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.
