**SUBJECT: Issuance of Suspension Order
to ALJUN12 CONSTRUCTION
SERVICES**

Pursuant to Sec. 69.1 (i) Rule XXIII of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (R.A.) 9184, and in accordance with Department Order No. 28, Series of 2024, this Suspension Order is hereby issued against **ALJUN12 CONSTRUCTION SERVICES**.

Based on the Approved Consolidated Three (3)-Strike Report, dated May 31, 2025, and posted on the DPWH Intranet on July 1, 2025, this contractor, bearing the PhilGEPS Registration No. 202212-326795-1227216554 and located at Blk 18 Lot 19 Hosea St. Exodus Floodway, Brgy Sta Ana, Taytay, Rizal, Region IV-A, has incurred three (3) strikes/offenses within a year from the approval date of the Resolution Recommending the Imposition of Strike One - First Warning. While the specific sub-offense categories vary among Implementing Offices (District Engineering Offices) - namely, (i) failure to include the list of Contractor's Major Construction and Laboratory Equipment Units to be assigned to the Contract supported by Certifications of Availability, and (ii) failure to comply with the required minimum number of key personnel and equipment as stated in the Bidding documents - all three (3) violations fall under the main strike offense category of "Submission of Patently Insufficient Bid."

ALJUN12 CONSTRUCTION SERVICES is disqualified from participating in any DPWH bidding processes, effective immediately upon receipt of the Notice of Suspension. This suspension shall remain in effect during any period of reconsideration or appeal until a final decision is rendered by the Office of the Secretary. However, this suspension does not apply to the contractor's participation in procurement activities of other government agencies.

This Order shall take effect immediately.
