) SUBJECT: Creation of Bukidnon Sub-District Engineering Office (DEO) in the Fourth Legislative District of Bukidnon, Region X

Series of 2022 Augusta 202

In the interest of the service and pursuant to Executive Order No. 124, Series of 1987 and Republic Act No. 10184, s.2012, "An Act Reapportioning the Province of Bukidnon into Four (4) Legislative Districts", and having met the criteria for DEO Creation per Department Order No. 110, Series of 2016, a DPWH Sub-DEO in the Province of Bukidnon, Region X, is hereby created and to be known as **Bukidnon Sub-District Engineering Office**.

As a result of this creation, the existing Bukidnon 1st DEO, Bukidnon 3rd DEO and the newly created Bukidnon Sub-DEO shall be classified and shall comprise of the following cities and municipalities as shown below:

Bukidnon Sub-DEO shall be constituted and manned by appropriate personnel from the Regional Office and other District Engineering Offices within the Region particularly from the existing Bukidnon $1^{\rm st}$ DEO and Bukidnon $3^{\rm rd}$ DEO and as may be identified by the Secretary/Regional Director of DPWH Region X.

In addition, Bukidnon 1^{st} DEO and Bukidnon 3^{rd} DEO having an equivalent road length of 312.327 km and 275.332 km, respectively, will maintain their current classification as 1^{st} class DEOs.

This Order supersedes other previous issuances in contrary thereto, and to become effective in the RBIA in FY 2023 in preparation of the succeeding DPWH Infrastructure Program.
