The DPWH Task Force "Baklas Billboards" shall ensure effective implementation of the pertinent provisions of the National Building Code of the Philippines (PD 1096), Administrative Orders 160 and 160-A, both series of 2006, and Memorandum dated 03 January 2014 nationwide.

In view of the issuance of Executive No. 165, series of 2022 entitled "*Prescribing Regulations* on Out-of-Home Advertising Signs and Signboards", the DPWH together with the DILG, DOF, DOST/PAGASA and CAAP is mandated to issue the Implementing Rules and Regulations (IRR) of the said EO.

This Order supersedes Special Order No. 103 dated May 17, 2023 and all other issuances inconsistent herewith, and shall take effect immediately.
