The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the Department of Public Works and Highways (DPWH) represented herein by **ESMERALDA O. DE GUZMAN, OIC - District Engineer**, duly authorized for this purpose, with main office address at **DPWH-Cagayan Third District Engineering Office, Tuguegarao City**, hereinafter referred to as the **"PROCURING ENTITY"**;

-and-

**COLORSHIELD CONSTRUCTION AND DEVELOPMENT CORPORATION** single proprietorship/ partnership/ corporation/joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at **Terminal Road, Cabaruan, City of Cauayan, Isabela**. Represented herein by **BONIFACIO D. TAGUBA** duly authorized for this purpose hereinafter referred to as the **"CONTRACTOR;"**

**WITNESSETH:**

**WHEREAS**, the **PROCURING ENTITY** is desirous that the **CONTRACTOR** execute the Works under **25BD0096 – Local Program – National Building Program - Buildings and Other Structures – Multipurpose/Facilities – Construction of Bureau of Fire Protection (BFP) Provincial Office, Peñablanca, Cagayan – Phase II**, hereinafter called "the Works," and the **PROCURING ENTITY** has accepted the Calculated Bid of the **CONTRACTOR** for the execution and completion of the Works at the calculated unit bid prices shown in the attached Bill of Quantities, or a total Contract price of **SIX MILLION SEVEN HUNDRED NINETY ONE THOUSAND THREE HUNDRED ONE PESOS AND 75/100 (P6,791,301.75)**.

**WHEREAS**, the **PROJECT** comprised in this Contract shall be completed within **One Hundred Seventy Two (172)** calendar days in accordance with the provisions of the Bidding Documents;

**WHEREAS**, under Republic Act 12116 (GAA FY 2025) the implementation of the projects is covered by the Cash Budgeting System as required under Executive Order 91, dated September 9, 2019;

NOW, THEREFORE, for and consideration of the foregoing premises, the parties hereto agree as follows:


