Contractors/Applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 7:00 am to 4:00 pm or at the DPWH website www.dpwh.gov.ph.

- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184).

Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **BDS ITB Clause 22**.
- 9. Bids must be duly received by the BAC Secretariat at the address below for manual submission or at <u>electronicbids dayaocity2@dpwh.gov.ph</u> for electronic submission on or before <u>August 26, 2025 until 10:00 A.M.</u> Late bids shall not be accepted.
- 10. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 15.
- 11. Bid opening shall be on <u>August 26, 2025</u>, <u>immediately after the deadline of the submission of bids</u>, at the Conference Room, Davao City II District Engineering Office and/or via Official Social Media of this office. Bids will be opened in the presence of the bidder's representatives who choose to attend at the address below.

The Department of Public Works and Highways Davao City II District Engineering Office, Davao City, reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
