The **DPWH Cagayan First District Engineering Office** through the **FY 2025 GAA Maintenance Fund** intends to apply the sum of **₱823,948.95** being the Approved Budget for the Contract (ABC) to payments under the contract **25BB0158: 41x – Emergency Projects – Removal of Obstruction (Common Borrow) due to Landslide at K532+350 to KM532+400 RS K0533+600 to K533+650 RS, K534+100 to K534+150 RS, K534+150 RS, K35+450 to K535+600 RS, K539+500 to K539+550 RS along Baybayog – Baggao – Dalin – Sta. Margarita Bolos Road (S00663LZ) Baggao, Cagayan**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The major category of work for the project is **RM Roads: Maintenance**
3. Prospective Bidders should be registered with and classified by the Philippine Contractors Accreditation Board (PCAB) with PCAB LICENSE Size Range of at least **Small A**.

Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, **while those already enrolled shall keep their records current and updated**. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 8:00 am to 5:00 pm or at the DPWH website www.dpwh.gov.ph.

4. Pursuant to GPPB resolution No. 15- 2021 dated October 14, 2021, prospective bidders shall submit in their first envelope the **Updated PhilGEPS Certificate of Platinum Registration and Membership** in accordance with Sections 23.3, 24.4.3 and 54 of Republic Act 9184 (RA 9184), all Class "A" Eligibility Documents covered by Section 8.5.2 of the 2016 revised IRR of RA 9184 supporting and veracity, authenticity and validity of the Certificate shall remain current and updated, and that **failure by the prospective bidder to update its PhilGEPS Certificate of Platinum Registration and Membership with the current and updated Class "A" Eligibility Documents** covered by Section 8.5.2 of the 2016 revised IRR of RA 9184 shall result in the automatic suspension of the validity of its Certificate of Platinum Registration and Membership until such time that all of the expired Class "A" Eligibility Documents has been updated.
5. Bidders are required to update their existing PhilGEPS Registration (Platinum) in the DPWH Civil Works Registry prior to the scheduled receipt and opening of bids.
6. Bidding will be conducted through open competitive bidding procedures using non-discretionary "*pass/fail*" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
7. Interested bidders may obtain further information from the **DPWH Cagayan First District Engineering Office** and inspect the Bidding Documents at **Procurement Staff, 2nd Floor Building, DPWH Cagayan First District Engineering Office, Aparri, Cagayan** during weekdays from **8:00 A.M. to 5:00 P.M.**
8. A complete set of Bidding Documents may be acquired by interested bidders on **June 27, 2025 – July 17, 2025** from the address below and upon payment of the applicable and refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Pesos (₱ 1,000.00).**

Prospective bidders shall present their **ORIGINAL OFFICIAL RECEIPT OF PAYMENT** for Bid Documents (project specific) to the BAC Secretariat of this Office before the deadline stated above for inclusion in the list of contractors for eligibility processing. The following are the only authorized persons to purchase/submit bids: **(a) Company ID or any government issued ID, (b) Authorization Letter (if not authorized liaison officer in the CWA, i.e. Special of Attorney for Sole Proprietorship; or Board/Partnership/Joint Venture/Cooperative).**
9. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
10. The **DPWH Cagayan First District Engineering Office** will hold a **Pre-Bid Conference** on **July 4, 2025, 10:00 A.M.** at the **Procurement Conference Room, 2nd Floor Building, DPWH Cagayan First District Engineering Office, Aparri, Cagayan**, and/or through webcasting via YouTube Channel (DPWH Cagayan First

Procurement Livestream) which shall be open to prospective bidders. Prospective Bidders are encouraged to send their technical personnel to attend the Pre-Bid Conference.

11. Bid submission may be done **manually** or **electronically**. However, **bidders should only select one mode of submission**, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **BDS** Clause 17.
12. Strict Application of R.A. 9184 of Post-Qualification of Bidders with Delayed On-going Contracts with the DPWH, (Department Order No. 127 Series 2018). If at the time of post-qualification procedure, the BAC verifies that any of the deficiencies is due to the contractor's fault or negligence pursuant to 3a.3(b)(11)(c) of the 20'16 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184), the Procuring Entity shall disqualify the contractor from the award without any right to reimburse fees and incidental cost paid for the procurement contract subject of the Bid".
13. **Bids requested to be withdrawn in accordance with ITB Clause shall be returned unopened to the Bidders. A Bidder, who has acquired the bidding documents, may also express its intention not to participate in the bidding through a letter which should reach and be stamped by the BAC before the deadline of submission and receipt of bids. A Bidder that withdraws its bid shall not be permitted to submit another bid, directly or indirectly, for the same contract.**
14. Bids must be duly received by the BAC Secretariat at the address below for manual submission at the **New Conference Room, 2nd Floor Bldg., DPWH Cagayan First District Engineering Office, Aparri, Cagayan** or at **electronicbids_cagayan1@dpwh.gov.ph** for electronic submission and receipt of bids on or before **July 17, 2025 at 10:00 A.M.**. Late bids shall not be accepted.
15. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **BDS** Clause 15.1.
16. Bid opening shall be on **July 17, 2025 immediately after the deadline of the submission of bid** at the **Procurement Conference Room, 2nd Floor Bldg., DPWH Cagayan First District Engineering Office, Aparri, Cagayan**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.
17. The **DPWH Cagayan First District Engineering Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised IRR of RA 9184, updated as of July 19, 2024, without thereby incurring any liability to the affected bidder or bidders.


