



INVITATION TO BID (IB) No. 2025-INFR-084

For Contract ID No. 25LD0227 Construction of School Building, Coronon Elementary School, Sta. Cruz, Davao del Sur

1. The **DPWH, Davao del Sur DEO**, through the **Basic Educational Facilities Fund (BEFF) for CY 2025** intends to apply the sum of **Four Million Nine Hundred Seventy-Five Thousand Pesos Only (Php 4,975,000.00)** being the Approved Budget for the Contract (ABC) to payment under the Contract ID No. **25LD0227**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DPWH, Davao del Sur DEO** through its **Bids and Awards Committee (BAC)** now invites bids for the hereunder Works:

Bidders should have completed a contract similar to the Project. The description of an eligible bidders is contained in the Bidding Documents, particularly, in Section II (Instruction to Bidders).

3. Prospective Bidders should be registered with and classified by the Philippine Contractors Accreditation Board (PCAB) with PCAB LICENSE Size Range of at least **Small B (License Category "C & D")**.

Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5th Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 7:00 am to 4:00 pm or at the DPWH website www.dpwh.gov.ph.

4. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Updated 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
5. Interested bidders may obtain further information from the **DPWH, Davao del Sur District Engineering Office** and inspect the Bidding Documents at the address given below during weekdays from **8:00 A.M. to 5:00 P.M.**
6. A complete set of Bidding Documents may be acquired by interested bidders starting **June 23, 2025 until before 10:00 A.M. of July 15, 2025** from the given address and websites below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic means.
7. The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity (DPWH), provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
8. The **DPWH, Davao del Sur DEO** will hold a Pre-Bid Conference on **June 30, 2025 (2:00 P.M.)** at Conference Room, DPWH, Davao del Sur DEO, Lapu-lapu St., Digos City, also accessible through **YouTube Live** (<http://www.youtube.com/@DPWH.DDS.DE01>), which shall be open to prospective bidders.
9. Bid submission may be done **manually** or **electronically**. However, **bidders should only select one mode of submission**, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the ITB Clause 17.
10. Bids must be duly received by the BAC Secretariat at the address below for manual submission or at **electronicbids_davaodelsur@dpwh.gov.ph** for electronic submission on or before **July 15, 2025 (until 10:00 A.M.)**. Late bids shall not be accepted.
11. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 15.
12. Bid opening shall be on **July 15, 2025 (10:00 A.M.)** at Conference Room, DPWH, Davao del Sur DEO, Lapu-lapu St., Digos City. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
13. The **DPWH, Davao del Sur DEO** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 RIRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
