- Prospective Bidders should be (1) registered with and classified by the Philippine Contractors Accreditation Board (PCAB) with PCAB LICENSE Category for license classification stated above. The description of an eligible Bidder is contained in the Bidding Documents, particularly, in Annex II-1.1 B Section II and III of Bidding Documents.

Contractors/applicants who wish to participate in this bidding are encouraged to enroll in the DPWH Civil Works Application (CWA) at the DPWH Procurement Service (PrS), 5<sup>th</sup> Floor, DPWH Bldg., Bonifacio Drive, Port Area, Manila, while those already enrolled shall keep their records current and updated. The Contractor's eligibility to bid on the project will be determined using the DPWH Contractor Profile Eligibility Process (CPEP) and subject to further post-qualification. Information on registration can be obtained from the PrS during working weekdays from 7:00 am to 4:00 pm or at the DPWH website [www.dpwh.gov.ph](http://www.dpwh.gov.ph).

- Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
- Interested bidders may obtain further information from the **DPWH Regional Office X** and inspect the Bidding Documents at **BAC - Secretariat - DPWH Regl. Office X** during weekdays from **8:00 A.M – 5:00 P.M**
- A complete set of Bidding Documents may be acquired by interested bidders starting on **June 4, 2025 until the submission of Bids** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines by the GPPB, in the amount stated above.
- It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

8. The **DPWH Regional Office X** will hold a Pre-Bid Conference on **June 11, 2025 at 2:00 P.M** at **BAC-Bidding Rm. DPWH Region X, Bulua, Cagayan de Oro City**, which shall be open to prospective bidders.
9. Bid submission maybe done manually or electronically/online. However, bidders should only select one mode of submission, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **BDS**.
10. Bids must be duly received by the BAC Secretariat at the address below for manual submission or at **electronicbids\_r10@dpwh.gov.ph** for electronic submission on or before **June 23, 2025 until 10:00 A.M.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18. Late Bids shall not be accepted.  
  
**Bid Proposals may be submitted through an authorized representative together with the original Special Power of Attorney (SPA) for Sole Proprietorship; or Board/Partnership/Joint Venture Resolution with Secretary's Certificate for Corporation/Partnership/Joint Venture/Cooperative) which is Contract Specific and presentation of Company ID or any government issued ID.**
11. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB clause 15.
12. Bid opening shall be on **June 23, 2025 immediately after the deadline for the submission of bid**, at **BAC-Bidding Rm. DPWH Region X, Bulua, Cagayan de Oro City** and/or through zoom. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below.
13. The **DPWH Regional Office X** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
