The negotiation shall be proceeded pursuant to the provisions of **DIRECT PURCHASE UNDER SECTION 50 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF RA 9184 AND SECTION 53.14 OF GPBB RESOLUTION NO. 24-2019 as follows:**

Section 53.14 Direct Retail Purchase of Petroleum Fuel, Oil and Lubricant (POL) Products and Airline Tickets. Where Goods and Services are required by a Procuring Entity for the efficient discharge of its principal mandate, governmental functions, or day-today operations, direct retail purchase of (i) petroleum fuel, oil and lubricant (POL) products; and (ii) airline tickets may be made by end-users delegated to procure the same from identified direct suppliers or service providers.

For Negotiated Procurement under Section 53.14, the BAC and the HOPE through a Resolution and issuance for the purpose, respectively, shall delegate to specific officials, personnel, committee or office in the Procuring Entity the conduct of Direct Retail Purchase to efficiently and expeditiously deal with the pressing need sought to be addressed
