During the **Pre-Bid Conference** held on June 3, 2025, it was discussed and agreed to revise the **Minimum Key Personnel Requirements** by including the following additional positions:

- One (1) Accredited Safety Officer, and
- One (1) Certified First Aider

It is also clarified that the **Project Engineer** must be **accredited as per Department Order No. 118, series of 2024**.
