- 1. All entries must be typewritten or legibly written.
- 2. The Approved Budget for the Contract is Php 385,000.00.
- 3. Only Bids of Bidders found to be legally, technically, and financially capable will be evaluated.
- 4. The first envelope shall contain the eligibility and technical documents of the Bid as specified:
 - a. PhilGEPS Certificate of Platinum Registration
 - b. Organizational Chart for the contract to be bid
 - c. List of Contractor's Key Personnel to be assigned to the Contract with their relevant qualification data, and
 - d. Omnibus Sworn Statement in the form prescribed by GPPB.
- 5. The second bid envelope shall contain the financial documents for the Bid as specified
 - a. Bid Form
 - b. Bid Prices in this Request for Quotation Form
 - c. Detailed Estimates including a Summary Sheet indicating the unit prices of construction materials, labor rates, and equipment rentals in coming up with the bids
 - d. Quarterly/Monthly Cash Flow and Payment Schedule
- 6. Bid prices may be quoted in the local currency or tradeable currency accepted by the BSP at the discretion of the Bidder. Payment of the Contract Price shall be made in Philippine Pesos
- 7. Each Bidder shall submit one copy of its first and second components of its Bid.
- 8. The key personnel must meet the required minimum years of experience set below:

9. Performance Security is Required. Within ten (10) calendar days from receipt of the Notice of Award from the Procuring Entity but in no case later than the signing of the contract by both parties, the successful Bidder shall furnish the performance security in any of the forms prescribed in Section 39 of the 2016 revised IRR.

10. Warrranty Security is required. The warranty against Structural Defects/Failures, except that occasioned-on force majeure, shall cover a period of one (1) year from the date of issuance of the Certificate of Final Acceptance by the Procuring Entity.

11. The DPWH Standard Specifications for Public Works and Highways ("Blue Book") shall be the main basis for the standards and codes to be met by the goods and materials to be furnished and work performed or tested for the Contract.

- The prospective bidder must submit PhilGEPS Platinum Registration Certificate during the submission of bids/quotations. Per GPPB Resolution No. 15-2021, prospective bidders are required to upload and maintain current the following eligibility documents in the PhilGEPS:
 - a. Registration Certification (SEC/DTI Registration)
 - b. Mayor's/Business permit or its Equivalent Documents
 - c. Tax Clearance
 - d. PCAB License and Registration for Infrastructure Projects; and
 - e. Audited Financial Statements

Any expired document among the afore-cited eligibility documents shall render the PhilGEPS Platinum Registration Certificate as automatically suspended and its validity shall resume only once the said expired document is already updated with the PhilGEPS.

- 4. Bid submission may be done manually or electronically/online. However, bidders should only select one mode of submission, either manual or electronic.
