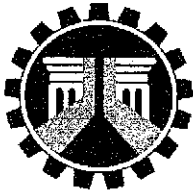

THIS AGREEMENT, made this 13 JUL 2020, by and between:

OCLARIT, District Engineer**, duly authorized for this purpose, with main office address at **DPWH 2nd District Engineering Office, Bislig City, Surigao del Sur**, hereinafter referred to as the **"PROCURING ENTITY"**;

SICCIÓN SURVEYING OFFICE, existing under and by virtue of laws of the Republic of the Philippines, with main office address at 1449-1453 AH Lacson St., Sta Cruz, Manila, represented herein by **ROLANDO C. SICCIÓN, Proprietor/General Manager**, duly authorized for this purpose, hereinafter referred to as the **"Consultant."**


