This **CONTRACT AGREEMENT**, made this **3rd day of May, 2023**, by and between:

The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the **Department of Public Works and Highways (DPWH)** represented herein by **ARNOLD A. SABUG**, duly authorized for this purpose, with main office address at Mangandingay, Cabarroguis, Quirino, hereinafter referred to as the **"PROCURING ENTITY"**;

A.P.D. CONSTRUCTION, INC. a single proprietor/partnership/corporation/joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at **Puzon Subdivision, San Fermin, Cauayan City, Isabela**, represented herein by **VICTORINO R. DY**, duly authorized for this purpose, hereinafter referred to as the **"CONTRACTOR"**;

WITNESSETH:

WHEREAS, the PROCURING ENTITY is desirous that the CONTRACTOR execute the Works under **23BK0105 - Concreting of Brgy. Palacian to Brgy. Diodol FMR , Brgy. Palacian, Aglipay, Quirino**, hereinafter called "the **WORKS**," and the PROCURING ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the calculated unit bid prices, or a total of Contract price of **Twelve Million Two Hundred Fifty Thousand Five Hundred Twenty Five Pesos and Sixty Five Centavos (P 12,250,525.65).**

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
 - d. Notice of Award of Contract and the Bidder's conforme thereto; and
 - e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Twelve Million Two Hundred Fifty Thousand Five Hundred Twenty Five Pesos and Sixty Five Centavos (P 12,250,525.65)** or such other sums as may be ascertained, **CONTRACTOR** agrees to implement **23BK0105 - Concreting of Brgy. Palacian to Brgy. Diodol FMR , Brgy. Palacian, Aglipay, Quirino** in accordance with its Bid;
4. The **DPWH** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




