CONTRACT AGREEMENT

This **AGREEMENT**, made this 26th day of June, 2025, by between the **Department of Public Works and Highways (DPWH) Batangas 1st District Engineering Office** represented herein by **ABELARDO D. CALALO** duly authorized for this purpose with main office address at Brgy. Lanatan, Balayan, Batangas, hereinafter called the "**ENTITY**" and **RUSMEN BUILDERS & DEVELOPMENT CORPORATION**, with main office address at **San Pascual, Batangas** represented herein by **RUSTICO C. MENDOZA** duly authorized for this purpose, hereinafter called the "**CONTRACTOR**".

WHEREAS, the **ENTITY** is desirous that the **CONTRACTOR** execute **Contract ID No. 24DB0161 - Concreting of Barangay Tumulim FMR, Barangay Tumulim, Nasugbu, Batangas** herein called "**the Works**" and the **ENTITY** has accepted the Bid for **Fourteen Million Four Hundred Seventy-Seven Thousand Five Hundred Pesos Only (P14,477,500.00)** by the **CONTRACTOR** for the execution and completion of such Works and the remedying of any defects therein. The whole Works shall be completed within **one hundred fifty (150) calendar days** in accordance with the provisions of this contract.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this **AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents as required by the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form, and be read and construed as part of this **AGREEMENT**, viz.:

 - v. Supplemental/Bid Bulletins, if any;
 - b. Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

In consideration of the payments to be made by the **PROCURING ENTITY** to the **CONTRACTOR** as hereinafter mentioned the **CONTRACTOR** hereby covenants with the **PROCURING ENTITY** to execute and complete the Works and remedy any defects therein in conformity with the provisions of this **CONTRACT AGREEMENT** in all respects. ***Furthermore, a slippage of more than 30 days from the original schedule would result in nonpayment, cancellation of the contract, blacklisting of the erring contractor, and the entry of new contractor who will finish the project.***
4. In consideration for the sum of **Fourteen Million Four Hundred Seventy-Seven Thousand Five Hundred Pesos Only (P14,477,500.00)** or such other sums as may be ascertained, **RUSMEN BUILDERS & DEVELOPMENT CORPORATION**, agrees to execute and complete the **Works** in accordance with his/her/its Bid.
5. The **Department of Public Works and Highways (DPWH) Batangas 1st District Engineering Office** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

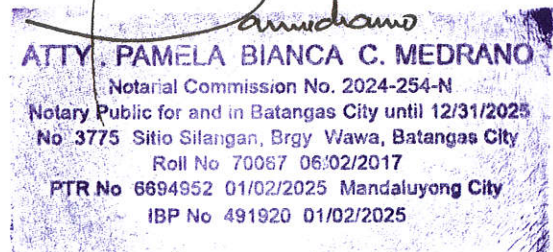
