DE GUZMAN, OIC - District Engineer**, duly authorized for this purpose, with main office address at **DPWH-Cagayan Third District Engineering Office, Tuguegarao City**, hereinafter referred to as the "**PROCURING ENTITY**";

E. GUADIZ CONSTRUCTION single proprietorship/ partnership/ corporation/joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at **Brgy. Centro West (Pob.) Ballesteros, Cagayan**. Represented herein by **EMELYN E. GUADIZ** duly authorized for this purpose hereinafter referred to as the "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the **PROCURING ENTITY** is desirous that the **CONTRACTOR** execute the Works under **25BD0101– Sustainable Infrastructure Projects Alleviating Gaps (SIPAG) – Access Roads and/or Bridges from the National Road/s leading to Major/Strategic Public Buildings/Facilities – Construction of Local Road, Barangay Cadaanan, Solana, Cagayan**, hereinafter called "the Works," and the **PROCURING ENTITY** has accepted the Calculated Bid of the **CONTRACTOR** for the execution and completion of the Works at the calculated unit bid prices shown in the attached Bill of Quantities, or a total Contract price of **FOUR MILLION EIGHT HUNDRED FIFTY THOUSAND THREE HUNDRED EIGHTY FIVE PESOS AND 51/100 (P4,850,385.51)**.
