The **GOVERNMENT OF THE REPUBLIC OF THE PHILIPPINES** through the Department of Public Works and Highways (DPWH) represented herein by **ESMERALDA O. DE GUZMAN**, **OIC - District Engineer**, duly authorized for this purpose, with main office address at **DPWH-Cagayan Third District Engineering Office**, **Tuguegarao City**, hereinafter referred to as the "**PROCURING ENTITY**";

**<u>5MJ'S CONSTRUCTION</u>** single proprietorship/ partnership/ corporation/joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at <u>Centro Southwest (Pob.), Solana, Cagayan</u>. Represented herein by <u>VICTORIA P. MONTANO</u> duly authorized for this purpose hereinafter referred to as the "CONTRACTOR;"

## WITNESSETH:

**WHEREAS**, the PROCURING ENTITY is desirous that the CONTRACTOR execute the Works under **25BD0055 Re-ad** – **Basic Infrastructure Program** (**BIP**) – **Multi-Purpose Buildings/Facilities to Support Social Services** – **Construction of Multi-Purpose Building**, **Peñablanca East Central School, Peñablanca, Cagayan**, hereinafter called "the Works," and the PROCURING ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the calculated unit bid prices shown in the attached Bill of Quantities, or a total Contract price of <u>FOUR MILLION SEVEN HUNDRED EIGHTY SIX THOUSAND FIVE</u> **HUNDRED SEVEN PESOS AND 72/100 (P4,786,507.72).** 

**WHEREAS**, the **PROJECT** comprised in this Contract shall be completed within **One Hundred Sixty Nine (169)** calendar days in accordance with the provisions of the Bidding Documents;

**WHEREAS,** under Republic Act 12116 (GAA FY 2025) the implementation of the projects is covered by the Cash Budgeting System as required under Executive Order 91, dated September 9, 2019;

NOW, THEREFORE, for and consideration of the foregoing premises, the parties hereto agree as follows:

- 1. In this **CONTRACT AGREEMENT**, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as part of this **CONTRACT AGREEMENT**, and shall be interpreted in the following order of priority:
