DE GUZMAN, OIC - District Engineer**, duly authorized for this purpose, with main office address at **DPWH-Cagayan Third District Engineering Office, Tuguegarao City**, hereinafter referred to as the **"PROCURING ENTITY"**;

**4MD JSL CONSTRUCTION INC.**, single proprietorship/ partnership/ corporation/joint venture organized and existing under and by virtue of laws of the Republic of the Philippines, with main office address at **282 Quezon St., Centro Northwest (Pob.), Solana, Cagayan**. Represented herein by **MARCELO A. LAGUNDI** duly authorized for this purpose hereinafter referred to as the **"CONTRACTOR;"**

### WITNESSETH:

**WHEREAS**, the PROCURING ENTITY is desirous that the CONTRACTOR execute the Works under **25BD0100 – Basic Infrastructure Program (BIP) – Multi-Purpose Buildings/Facilities to Support Social Services – Construction of Multi-Purpose Building (Convertible to Evacuation Center), Barangay Nanuccauan, Amulung, Cagayan**, hereinafter called "the Works," and the PROCURING ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the calculated unit bid prices shown in the attached Bill of Quantities, or a total Contract price of **FOUR MILLION EIGHT HUNDRED NINETY NINE THOUSAND ONE HUNDRED NINETY EIGHT PESOS AND 32/100 (P4,899,198.32)**.

**WHEREAS**, under Republic Act 12116 (GAA FY 2025) the implementation of the projects is covered by the Cash Budgeting System as required under Executive Order 91, dated September 9, 2019;

NOW, THEREFORE, for and consideration of the foregoing premises, the parties hereto agree as follows:
