DE GUZMAN**, **OIC - District Engineer**, duly authorized for this purpose, with main office address at **DPWH-Cagayan Third District Engineering Office**, **Tuguegarao City**, hereinafter referred to as the **"PROCURING ENTITY";**

Represented herein by <u>VICTORIA P. MONTANO</u> duly authorized for this purpose hereinafter referred to as the "CONTRACTOR;"

WITNESSETH:

WHEREAS, the PROCURING ENTITY is desirous that the CONTRACTOR execute the Works under 25BD0114 – Basic Infrastructure Program (BIP) – Multi-Purpose Buildings/Facilities to Support Social Services – Completion of Multi-Purpose Building, Barangay Basi East, Solana, Cagayan, hereinafter called "the Works," and the PROCURING ENTITY has accepted the Calculated Bid of the CONTRACTOR for the execution and completion of the Works at the calculated unit bid prices shown in the attached Bill of Quantities, or a total Contract price of <u>TWO MILLION EIGHT HUNDRED SEVENTY SEVEN THOUSAND SEVEN HUNDRED FIFTY TWO PESOS AND 77/100 (P2,877,752.77).</u>
